An ace-high straight flush, commonly known as a royal flush, is the best possible hand in many variants of poker.

In 2 poker, players form sets of five playing cards, called hands, according to the rules of the game.[1] Each hand has 2 a rank, which is compared against the ranks of other hands participating in the showdown to decide who wins the 2 pot.[2] In high games, like Texas hold 'em and seven-card stud, the highest-ranking hands win. In low games, like razz, 2 the lowest-ranking hands win. In high-low split games, both the highest-ranking and lowest-ranking hands win, though different rules are used 2 to rank the high and low hands.[3][4]

Each hand belongs to a category determined by the patterns formed by its cards. 2 A hand in a higher-ranking category always ranks higher than a hand in a lower-ranking category. A hand is ranked 2 within its category using the ranks of its cards. Individual cards are ranked, from highest to lowest: A, K, Q, 2 J, 10, 9, 8, 7, 6, 5, 4, 3 and 2.[5] However, aces have the highest rank under ace-to-five high 2 or six-to-ace low rules, or under high rules as part of a five-high straight or straight flush.[6][7] Suits are not 2 ranked, so hands that differ by suit alone are of equal rank.[8] There are nine categories of hand when using a 2 standard 52-card deck, except under ace-to-five low rules where straights, flushes and straight flushes are not recognized. An additional category, 2 five of a kind, exists when using one or more wild cards. The fewer hands a category contains, the higher 2 its rank.[9] There are $52! / (5! \cdot 47!) = 311,875,200$ ways to deal 2 five cards from the deck but only $52! / (5! \cdot 47!) = 2,598,960$ distinct hands, because the order in which cards are dealt or arranged in a hand does not matter.[10] 2 Moreover, since hands differing only by suit are of equal rank, there are only 7,462 distinct hand ranks.[11]

Five 2 of a kind [edit]

Five of a kind, aces

Five of a kind is a hand that contains five cards 2 of one rank, such as 3 3 3 3 3 ("five of a kind, threes"). It ranks above a straight 2 flush but is only possible when using one or more wild cards, as there are only four cards of each 2 rank in the deck.[6] Five of a kind, aces, A A A A Jkr, becomes possible when a joker is 2 added to the deck as a bug, a form of wild card that may act

as a fifth ace.[5] Other 2 wild card rules allow jokers or other designated cards to represent any card in the deck, making it possible to 2 form five of a kind of any rank.[12] Each five of a kind is ranked by the rank of its quintuplet. 2 For example, Q Q Q Q Q ranks higher than 6 6 6 6 6.[6][13]

Straight flush [edit]

A jack-high 2 straight flush

A straight flush is a hand that contains five cards of sequential rank, all of the same suit, such 2 as Q J 10 9 8 (a "queen-high straight flush").[4] It ranks below five of a kind and above four 2 of a kind.[5] Under high rules, an ace can rank either high (as in A K Q J 10, an 2 ace-high straight flush) or low (as in 5 4 3 2 A, a five-high straight flush), but cannot simultaneously rank 2 both high and low (so Q K A 2 3 is an ace-high flush, but not a straight).[6][13] Under deuce-to-seven 2 low rules, an ace always ranks high (so 5 4 3 2 A is an ace-high flush). Under ace-to-six low 2 rules, an ace always ranks low (so A K Q J 10 is a king-high flush).[14] Under ace-to-five low rules, 2 straight flushes are not possible (so 9 8 7 6 5 is a nine-high hand).[7]

Each straight flush is ranked by 2 the rank of its highest-ranking card. For example, 10 9 8 7 6 ranks higher than 8 7 6 5 2 4, which ranks higher than 6 5 4 3 2. Straight flush hands that differ by suit alone, such as 2 7 6 5 4 3 and 7 6 5 4 3, are of equal rank.[6][13]

An ace-high straight flush, such as 2 A K Q J 10, is called a royal flush or royal straight flush and is the best possible hand 2 in ace-high games when wild cards are not used.[5][15][16] A five-high straight flush, such as 5 4 3 2 A, 2 is called a steel wheel and is both the best low hand and usually the best high hand of the 2 showdown in ace-to-five high-low split games.[4]

Four of a kind [edit]

Four of a kind, fives

Four of a kind, also 2 known as quads, is a hand that contains four cards of one rank and one card of another rank (the 2 kicker), such as 9 9 9 9 J ("four of a kind, nines"). It ranks below a straight flush and 2 above a full house.[5]

Each four of a kind is ranked first by the rank of its quadruplet, and then by 2 the rank of its kicker. For example, K K K K 3 ranks higher than 7 7 7 7 Q, 2 which ranks higher than 7 7 7 7 10. Four of a kind hands that differ by suit alone, such 2 as 4 4 4 4 9 and 4 4 4 4 9, are of equal rank.[6][13]

Full house [edit]

A 2 full house, sixes over kings

A full house, also known as a full boat or a tight or a boat (and 2 originally called a full hand), is a hand that contains three cards of one rank and two cards of another 2 rank, such as 3 3 3 6 6 (a "full house, threes over sixes" or "threes full of sixes" or 2 "threes full").[17][18] It ranks below four of a kind and above a flush.[5]

Each full house is ranked first by the 2 rank of its triplet, and then by the rank of its pair. For example, 8 8 8 7 7 ranks 2 higher than 4 4 4 9 9, which ranks higher than 4 4 4 5 5. Full house hands that 2 differ by suit alone, such as K K K J J and K K K J J, are of equal 2 rank.[6][13]

Flush [edit]

A jack-high flush

A flush is a hand that contains five cards all of the same suit, not 2 all of sequential rank, such as K 10 7 6 4 (a "king-high flush" or a "king-ten-high flush").[19] It ranks 2 below a full house and above a straight.[5] Under ace-to-five low rules, flushes are not possible (so J 8 4 2 3 2 is a jack-high hand).[7]

Each flush is ranked first by the rank of its highest-ranking card, then by the 2 rank of its second highest-ranking card, then by the rank of its third highest-ranking card, then by the rank of 2 its fourth highest-ranking card, and finally by the rank of its lowest-ranking card. For example, K J 9 6 4 2 ranks higher than Q J 7 6 5, which ranks higher than J 10 9 4 2, which ranks higher 2 than J 10 8 6 3, which ranks higher than J 10 8 4 3, which ranks higher than J 2 10 8 4 2. Flush hands that differ by suit alone, such as 10 8 7 6 5 and 10 2 8 7 6 5, are of equal rank.[6][13]

Straight [edit]

A ten-high straight

A straight is a hand that contains five 2 cards of sequential rank, not all of the same suit, such as 7

6 5 4 3 (a "seven-high straight"). It ranks below a flush and above three of a kind.[5] Under high rules, an ace can rank either high 2 (as in A K Q J 10, an ace-high straight) or low (as in 5 4 3 2 A, a 2 five-high straight), but cannot simultaneously rank both high and low (so Q K A 2 3 is an ace-high hand).[6][13] Under deuce-to-seven low rules, an ace always ranks high (so 5 4 3 2 A is an ace-high hand). Under 2 ace-to-six low rules, an ace always ranks low (so A K Q J 10 is a king-high hand).[14] Under ace-to-five 2 low rules, straights are not possible (so 10 9 8 7 6 is a ten-high hand).[7]

Each straight is ranked by 2 the rank of its highest-ranking card. For example, J 10 9 8 7 ranks higher than 10 9 8 7 2 6, which ranks higher than 6 5 4 3 2. Straight hands that differ by suit alone, such as 9 2 8 7 6 5 and 9 8 7 6 5, are of equal rank.[6][13]

An ace-high straight, such as A K 2 Q J 10, is called a Broadway straight,[20] while a five-high straight, such as 5 4 3 2 A, is 2 called a baby straight,[21] bicycle or wheel and is the best possible hand in ace-to-five low games (where it is 2 a high card hand, not a straight).[22][23]

Three of a kind [edit]

Three of a kind, queens

Three of a kind, 2 also known as trips or a set, is a hand that contains three cards of one rank and two cards 2 of two other ranks (the kickers), such as 2 2 2 K 6 ("three of a kind, twos" or "trip 2 twos" or a "set of twos"). It ranks below a straight and above two pair.[5]

Each three of a kind is 2 ranked first by the rank of its triplet, then by the rank of its highest-ranking kicker, and finally by the 2 rank of its lowest-ranking kicker. For example, 6 6 6 Q 4 ranks higher than 3 3 3 K 2, 2 which ranks higher than 3 3 3 J 7, which ranks higher than 3 3 3 J 5. Three of 2 a kind hands that differ by suit alone, such as 9 9 9 10 8 and 9 9 9 10 2 8, are of equal rank.[6][13]

In community card games, such as Texas hold 'em, three of a kind is called a 2 set only when it comprises a pocket pair and a third card on the board.[24]

Two pair [edit]

Two pair, 2 jacks and threes

Two pair is a hand that contains two cards of one rank, two cards of another rank and 2 one card of a third rank (the kicker), such as J J 4 4 9 ("two pair, jacks and fours" 2 or "two pair, jacks over fours" or "jacks up").[17][25] It ranks below three of a kind and above one pair.[5]

Each 2 two pair is ranked first by the rank of its higher-ranking pair, then by the rank of its lower-ranking pair, 2 and finally by the rank of its kicker. For example, 10 10 2 2 K ranks higher than 5 5 2 4 10, which ranks higher than 5 5 3 3 Q, which ranks higher than 5 5 3 3 2 J. Two pair hands that differ by suit alone, such as K K 7 7 8 and K K 7 2 7 8, are of equal rank.[6][13]

One pair [edit]

One pair, tens

One pair, or simply a pair, is a hand 2 that contains two cards of one rank and three cards of three other ranks (the kickers), such as 4 4 2 K 10 5 ("one pair, fours" or a "pair of fours"). It ranks below two pair and above high card.[5]

Each 2 one pair is ranked first by the rank of its pair, then by the rank of its highest-ranking kicker, then 2 by the rank of its second highest-ranking kicker, and finally by the rank of its lowest-ranking kicker. For example, 9 2 9 Q J 5 ranks higher than 6 6 K 7 4, which ranks higher than 6 6 Q J 2 2, which ranks higher than 6 6 Q 8 7, which ranks higher than 6 6 Q 8 3. One-pair 2 hands that differ by suit alone, such as 8 8 10 6 5 and 8 8 10 6 5, are 2 of equal rank.[6][13]

High card [edit]

High card, king

High card, also known as no pair or simply nothing, is a 2 hand that does not fall into any other category, such as K J 8 7 4 ("high card, king" or 2 "king-jack-high" or "king-high").[17][26] Note that under ace-to-five low rules, straights, flushes and straight flushes are not possible, so such hands 2 are instead high card hands.[7] It ranks below one pair.[5]

Each high card hand is ranked first by the rank of 2 its highest-ranking card, then by the rank of its second highest-ranking card, then by the rank of its third highest-ranking 2 card, then by the rank of its fourth highest-ranking card, and finally by the rank of its lowest-ranking card. For 2 example, K 6 5 3 2 ranks higher than Q J 6 5 3, which ranks higher than Q 10 2 8 7 4, which ranks higher

than Q 10 7 6 4, which ranks higher than Q 10 7 5 2 4, which ranks higher than Q 10 7 5 2. High card hands that differ by suit alone, such as 2 10 8 7 6 4 and 10 8 7 6 4, are of equal rank.[6][13] Under deuce-to-seven low rules, a seven-five-high 2 hand, such as 7 5 4 3 2, is the best possible hand.[27] Under ace-to-six low rules, where aces have 2 the lowest rank, a six-four-high hand, such as 6 4 3 2 A, is the best possible hand.[28] Under ace-to-five 2 low rules, where aces have the lowest rank and straights, flushes and straight flushes are not possible, a five-high hand, 2 such as 5 4 3 2 A or 5 4 3 2 A, commonly known as a bicycle or wheel, 2 is the best possible hand.[7][22]

Chiquita Brand encontrada culpable por un juri de Florida por ocho homicidios en Colombia

Una corte de Florida dictaminó que Chiquita Brands es responsable de ocho asesinatos cometidos por un grupo paramilitar de derecha que la compañía ayudó a financiar en una región fértil de Colombia durante el conflicto interno de décadas del país.

El jurado ordenó el lunes a la empresa productora de bananos multinacional que pague R\$38.3 millones a 16 miembros de las familias de agricultores y otros civiles que fueron asesinados en episodios separados por las Autodefensas Unidas de Colombia (AUC), un grupo paramilitar de derecha que Chiquita financió desde 1997 hasta 2004.

La compañía se ha enfrentado a cientos de demandas similares en tribunales de EE. UU. Presentadas por las familias de otras víctimas de la violencia del grupo paramilitar en Colombia, pero el veredicto de Florida representa la primera vez que Chiquita ha sido encontrada culpable. La decisión, que la compañía dijo que tiene la intención de apelar, podría influir en el resultado en otras demandas, según expertos legales.

El veredicto a favor de las víctimas es una instancia rara - en Colombia y en otros lugares - en la que una corporación privada es responsable de las víctimas por sus operaciones en regiones con violencia generalizada o inestabilidad social, dijeron expertos legales.

"Estamos muy contentos con el veredicto del jurado, pero no se puede escapar de que estamos hablando de abusos horribles", dijo Marco Simons, un abogado de EarthRights International, un grupo ambiental y de derechos humanos, quien representó a una familia en la demanda legal. Agnieszka Fryszman, otro abogada que representó a los demandantes, dijo: "La sentencia no devuelve a los esposos y hijos que fueron asesinados, pero establece el récord y coloca la responsabilidad por el financiamiento del terrorismo donde corresponde: en la puerta de Chiquita".

Los jurados llegaron a su decisión después de dos días de deliberación y seis semanas de juicio en el Tribunal de Distrito de EE. UU. En West Palm Beach, en el que los abogados debatieron sobre la motivación para los pagos que los ejecutivos de Chiquita admitieron hacer al grupo paramilitar.

El Departamento de Estado designó a las Autodefensas Unidas de Colombia como organización terrorista extranjera en 2001.

Chiquita, como parte de un acuerdo de culpa con el Departamento de Justicia para resolver cargos de hacer negocios con un grupo terrorista, admitió en 2007 haber pagado a los paramilitares R\$1.7 millones, según se reveló en una investigación.

Las Autodefensas Unidas de Colombia fueron un producto de la brutal guerra civil de Colombia, que estalló en la década de 1960 y mató a al menos 220,000 personas.

Se formaron en 1997 como una coalición de grupos de derecha pesadamente armados que los narcotraficantes y los hombres de negocios recurrieron para protegerse de los grupos guerrilleros de izquierda.

La guerra terminó en 2024 cuando el gobierno y el grupo guerrillero principal, que también fue responsable de matar civiles, firmaron un acuerdo de paz.

Los abogados que representan a las familias en el juicio de Florida argumentaron que las operaciones de Chiquita se beneficiaron de la relación de la empresa con el grupo paramilitar, que sembró el miedo en una región agrícola fértil de 7,000 millas cuadradas que conecta Panamá y Colombia hasta que se desmovilizó en 2006.

Dijeron que el grupo mató o obligó a los agricultores a irse, lo que permitió que Chiquita comprara tierras a precios deprimidos y expandiera sus operaciones convirtiendo las granjas de plátanos en granjas de banano más rentables.

Los abogados que representan a Chiquita cuestionaron si las víctimas habían sido asesinadas por los paramilitares o por otros grupos armados y dijeron que los empleados de la empresa también habían sido amenazados por los paramilitares. Los ejecutivos y empleados, dijeron los abogados defensores, estaban siendo extorsionados por las fuerzas de autodefensa y hacían pagos para garantizar su seguridad.

"La situación en Colombia fue trágica para tantos", dijo Chiquita en un comunicado después del veredicto. "Sin embargo, eso no cambia nuestra creencia de que no existe base legal para estas reclamaciones".

Algunas víctimas que fueron parte de la demanda fueron asesinadas frente a sus familiares, dijeron los abogados de los demandantes.

En un caso, una niña no identificada viajaba a una granja en un taxi con su madre y padrastro cuando fueron detenidos por hombres armados, dijeron los abogados durante el juicio. Los hombres ejecutaron al padrastro y luego dispararon fatalmente a la madre cuando intentó huir. Entonces dieron a la niña el equivalente a 65 centavos para tomar un autobús de regreso a la ciudad.
